- 6. Pre-bid meeting shall be held at [Saipal Rural Municipality] at [2082-09-28 14:00 Noon].5
- 7. Sealed or electronic bids must be submitted to the office [Saipal Rural Municipality, Kanda, Bajhang] by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before [12:00 noon] on [2082-10-08]. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at [14:00 Noon on 2082-10-08] at the office of [Kanda,Bajhang]. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of [Nrs 610000 (2 to 3 % of estimated amount without VAT and Contingencies but including PS)], which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
